OFFICIAL CONTEST RULES & REGULATIONS

"Pumpkin Carving Contest"

"Pumpkin Carving Contest" (the "Contest") is sponsored by Pembina West Co-op (the "Sponsor"). The Contest opens 8:00 am MST October 6, 2021 (the "Contest Start Date") and ends 8:00 am MST October 29, 2021 (the "Contest Closing Date"), known as the "Contest Period".

The Contest is being promoted at Pembina West Co-op Food Stores ("Participating Stores").

1. HOW TO ENTER:

NO PURCHASE NECESSARY. A purchase will not increase your chance of winning.

There is one (1) way to enter the Contest, as follows:

Enter by posting a photo of your carved pumpkin to the Pembina West Facebook page as a comment on the contest post. Photos must be the creation of the contest entrant, and be taken within the Contest Period.

2. ELIGIBILITY:

Eligible

To enter the Contest and be eligible to win a prize in the Contest, a person must be a resident of or live-in proximity to the Pembina West Co-op trading area (Barrhead, Mayerthorpe, Whitecourt and surrounding areas) ("Trading Area").

Not Eligible

Residents outside of the Trading Area are not eligible to enter the Contest.

The Sponsor's employees and the Sponsor's Board of Director as well as the immediate family* and those domiciled with the Sponsor's employees and Board of Directors are not eligible to participate in the Contest or win prizes in the Contest.

*"Immediate family" means members living in the same household.

3. PRIZE:

One (1) Halloween Gift Basket

APPROXIMATE RETAIL VALUE \$40

Prize must be claimed at a participating Pembina West Co-op Food Store, or if the winner resides in the Whitecourt area and is unable to claim at a Pembina West Co-op Food Store, can be claimed at the Pembina West Co-op Whitecourt C-Store.

Prizes must be accepted as awarded. Prizes may not be converted to cash, are non-transferable, and no substitutions are permitted. One prize per winning entry; one prize per household. The Sponsor reserves the right, in the event that a prize or any component of a prize cannot be awarded as described for any reason, to substitute another prize of equal or greater value without liability.

4. PRIZE WINNER:

One (1) winner will be determined by judges from the Pembina West Co-op Barrhead produce department from all eligible entries received by 8:00 am on Friday, October 29th. Winner will be announced by close of business Friday, October 29th on the Pembina West Co-op Facebook page. The selected entrant will be announced and must be present and identify themselves immediately to claim their prize. If a selected entrant is not present or does not make their presence known their entry will be disqualified and another entrant will be selected. To be declared a prize winner (the "Prize Winner"), the selected entrant (or parent/guardian of a minor entrant) must: complete, sign and return a Statement of Compliance, Release and Indemnity Agreement to the Sponsor or prize will be forfeited and an

alternate Prize Winner selected. Prize Winners consent to the use of their name, photograph and video without compensation, in any future publicity carried out by the Sponsor or the Participating Stores.

5. GENERAL:

By entering the Contest, entrants agree to abide by these Official Rules and the decisions of the Sponsor with respect to all aspects of the Contest, which are final. This Contest is subject to all applicable federal, provincial and municipal laws. The Sponsor reserves the right to disqualify any entrant in the event of fraudulent Contest entry or other violation of these Official Rules. Entries are subject to verification and void if obtained illegitimately, or if altered, mutilated, forged, tampered with, or irregular in any way.

Subject to applicable law, the Sponsor reserves the right, in its sole discretion and for any reason, to cancel, terminate, modify these Official Rules or administration of the Contest or suspend this Contest in whole or in part without prior notice and with no obligation or liability. In the Sponsor's sole discretion, a Prize Winner may be selected by selecting among all valid entries received up to the time of cancellation, termination or suspension.

By participating in the Contest, entrants agree to release and indemnify the Sponsor and any independent judging organization as well as their respective parents, affiliates, agents and contractors, including advertising and promotional agencies, and their directors, officers and employees, from any and all losses, expenses (including legal fees), damages and claims of any kind in connection with the Contest or resulting from the acceptance, possession or use of any prize, including without limitation any loss, personal injury, death, property damage, or claims based on publicity rights, defamation or invasion of privacy.

Under no circumstances will the Sponsor, its subsidiaries, affiliates, independent contractors, and their respective directors, officers, employees, and agents, including advertising and promotional agencies, be responsible for any injuries, loss or damages of any kind (compensatory, direct, incidental, indirect, consequential or otherwise) with respect to or in any way arising from, this Contest or the prize awarded. In no event shall the Sponsor be required to award more prizes than what is indicated in these Official Rules or award the prizes otherwise than in accordance with these Official Rules.

6. PRIVACY:

The Sponsor, Pembina West Co-op, respects your right to privacy. Personal information collected is not sold, rented or loaned to any third parties. The Sponsor may use the information collected to administer the Contest.

Pembina West Co-op will handle personal information in accordance with its privacy policies and practices, which can be accessed by contacting Pembina West Co-operative Administrative Office and in accordance with applicable laws. By completing and submitting a Contest entry form you consent to the collection use and disclosure of your personal information for the purposes stated herein.
